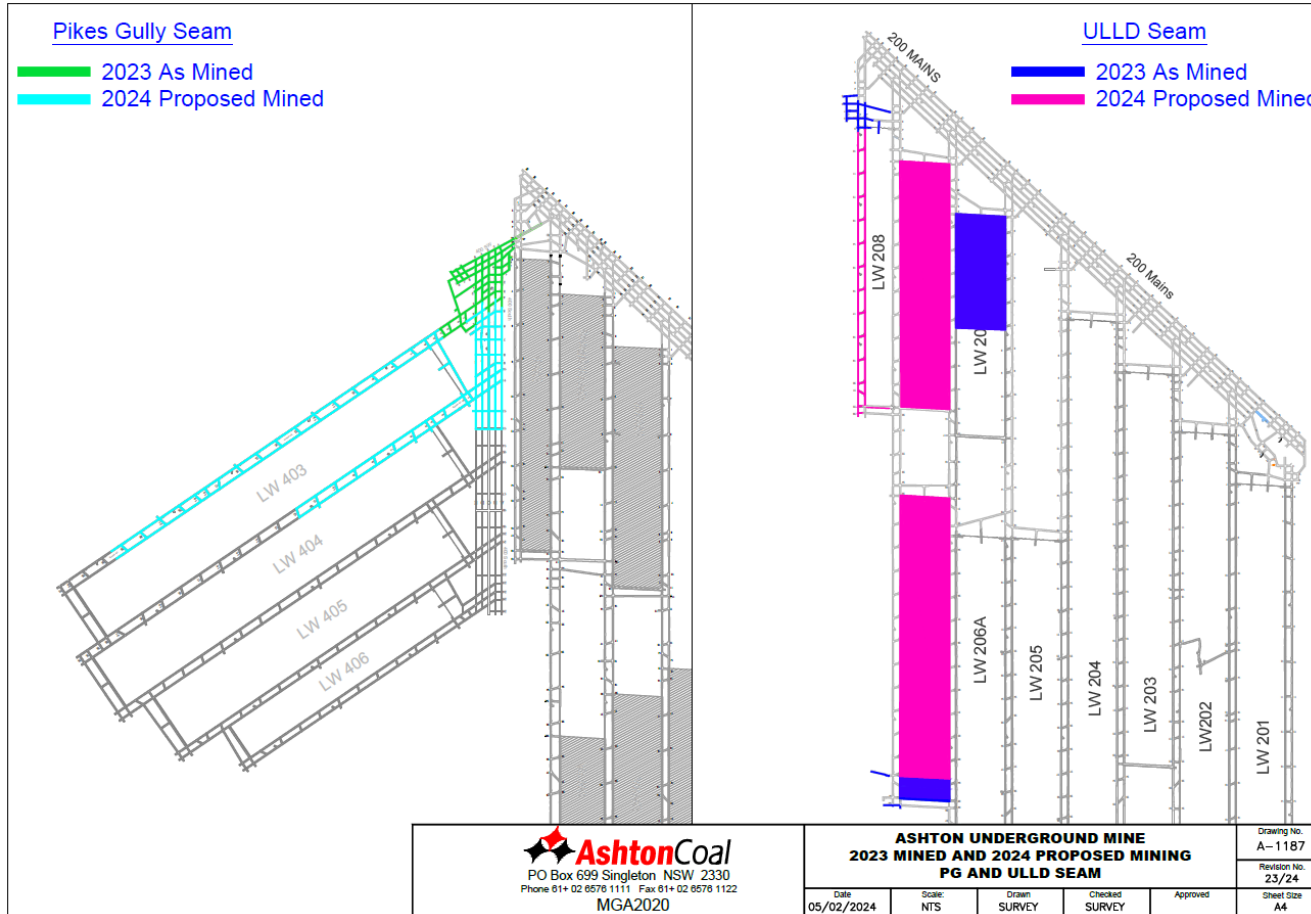

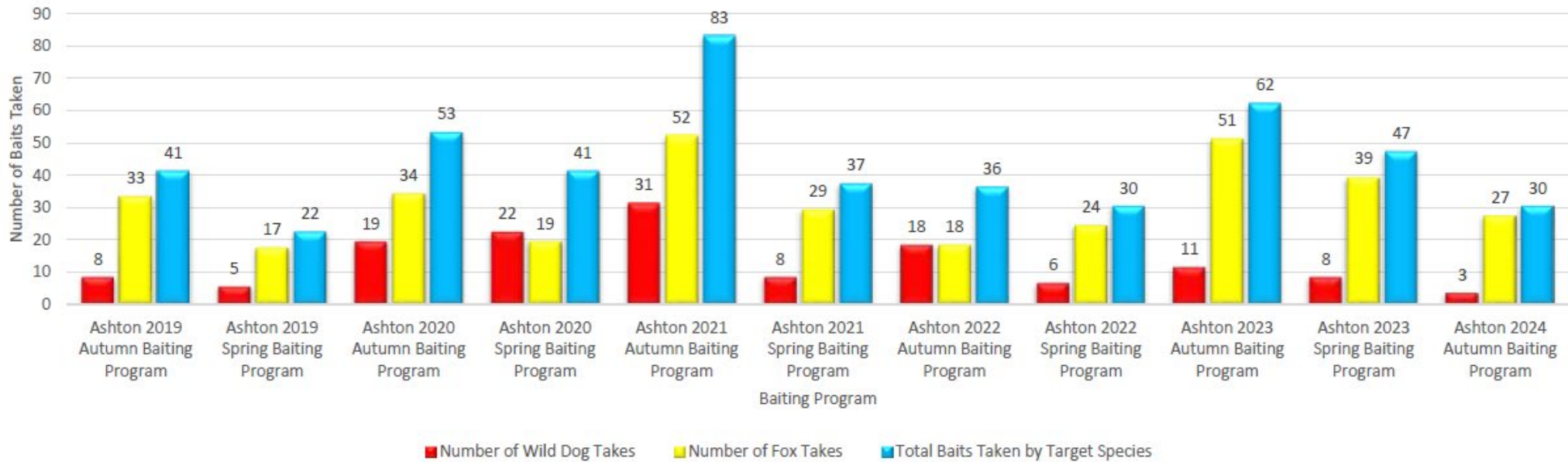
# Wild Dog & Fox Bait locations

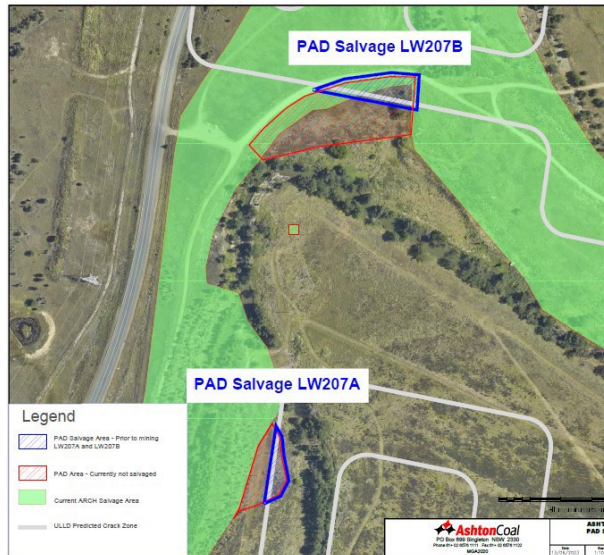

# Recent Archaeological Works Completed

## LW207A Salvage – AHIMS Site 37-3-0496

- Aboriginal archaeological salvage excavations within PAD area of recorded Aboriginal archaeological site #37-3-0496. Site is located on an elevated above Bowmans
- A grid was place across the area to be impacted by subsidence and a series of 1m x 1m archaeological test probes excavated to determine the densities of artefacts and where an open area excavation may be required.
- Following the test pitting, an open area excavation commenced at the area of highest artefact concentration
- Due diligencve inspection

- Commence artefact cleaning/analysis works



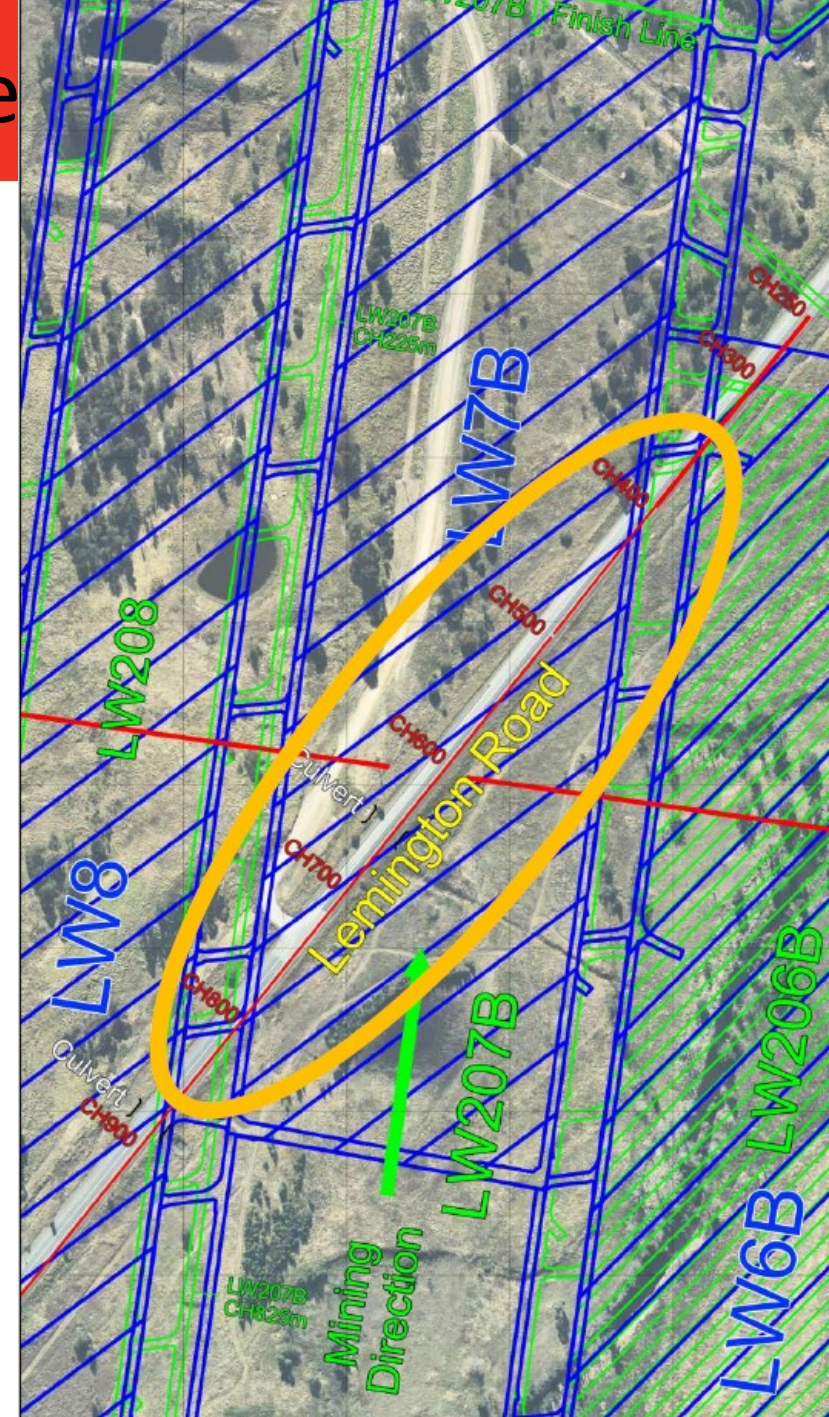
